The programs have been granted accreditation for further 3 years. **Sir C R Reddy College of Engineering, Vatluru, Eluru-West Godavari District, Andhra Pradesh-534007** should submit fresh online application under through eNBA portal not before five months from the expiry of validity of accreditation mentioned above.
