- 13. Hall tickets will be issued for the Semester end Examinations only after the students clear all the dues including hostel dues.

14 All candidates, provisionally selected for admission will be required to pay the prescribed

tuition fee and other specified fee. Failure of the same will result in the cancellation of

provisional admission. No portion of any fee, once paid, will be refunded under any

circumstances.

15 All the students should wear their Identity Cards instead of keeping them in pockets.

16 All the students should follow the uniform prescribed. They should strictly follow the dress

code in the subsequent years of their study. Wearing shoes is compulsory in the campus.

17 Formal civil dress code should be followed on Saturdays.

18 Ragging within or outside the college campus is strictly prohibited under prohibition of ragging

in Educational Institution Act of 26 of 1977. A student against whom there is prima facie

evidence of ragging in any form will be viewed seriously according to Ragging Act.

19 Misconduct committed by a student outside the college campus but having the effect of

damaging, undermining and tarnishing the image and reputation of the institution will make

the student concerned liable for severe disciplinary action to the extent of expelling from the

institution.

Prohibition of Ragging in Educational Institution Act-26 of 1997

SALIENT FEATURES

- 1. Ragging within or outside any Educational institutions is prohibited.
- 2. Ragging means doing an act which causes or is likely to cause insult / annoyance / fear / apprehension / threat / intimidation / outrage of modesty or injury to a student.

Nature of Ragging

- 1. Teasing, Embarrassing and humiliation
- Assaulting or using criminal force or criminal intimidation.
- Wrongfully restraining or confining or Causing hurt.
- 4. Causing grievous hurt, kidnapping or rape or committing unnatural offence.
- 5. Causing death or abetting suicide

Punishment

Imprisonment up to 6 months of fine up to Rs.1000/- or both.

Imprisonment up to 1 year or fine up to Rs.2000/- or both.

Imprisonment up to 2 years or fine up to Rs. 5000/- or both.

Imprisonment up to 5 years and fine up to Rs 10,000/-

Imprisonment up to 10 years and fine up to 50,000/-

NOTE:

- 1. A student convicted of any of the above offences will be expelled from the College.
- 2. A student imprisoned for more than six months for any of the above offences will not be admitted in any other College.
- 3. A student against whom there is prima facie evidence of ragging in any form will be suspended from the College immediately.
